# **Updates**

#### **Bylaws Revision:**

**Grace Massey** reported that the Bylaws now have the language for electronic voting and will be sent to AKC for final approval . All other sections of the revised Bylaws have been approved by AKC. Once approval is received from AKC they will be sent to the ATCA membership for approval.

The Board approved the Bylaws unanimously.

**AKC Canine College:** Kerrie Bryan reported that what began as a simple video to be produced by AKC has become a complex on-line Continuing Education course for AKC judges. The final work now being done is to ensure the accuracy of the program in relation to the standard for Australian Terriers.

### Sustainability Committee Report.

Vicki McKee reported that the Sustainability Committee will emphasize showcasing the breed on all Social Media including Instagram. To this end, the committee will consider non-members, in adjunct roles. The committee will explore absorbing the Breed Marketing committee into its provenance.

The committee is also working a survey for members.

## **Health Committee Report:**

Teresa Schreeder reported that she has received the first of Dr. Hess's monthly updates. Dr Hess's manuscript was submitted in March and the approval is still in process.

The eye clinic at the National Specialty had at this time 10 dogs signed up, but more were expected on the day of the clinic.

She has approached a veterinarian, Dr. Popkin, to administer CHIC testing (except eyes) at the 2021 National in Sacramento. The cost would be \$140 per dog for patellas and thyroids.
